SUBJECT: **ORDER OF THE ARROW - NATIONAL LEADERSHIP SEMINAR - NOVEMBER 2009**

The last Order of the Arrow National Leadership Seminar conducted by the Central Region in 2010 will be held at Heartland Center, Parkville, MO on November 12-14, 2010. **This is a National Order of the Arrow event.**

FEE: Youth \$ 180.00 Adult \$ 190.00

**ALLOCATION:** **Each lodge may send up to eight arrowmen, provided the number of youth is greater than or equal to the number of adults attending.** Excess lodge reservations will be placed on a waiting list. If NLS is not full 30 days in advance, reservations will be taken from the waiting list. Most lodges pay for their officers fees. This location fills very fast.

**ACCOMMODATIONS:** Housing for this event will be in cabins. All linens, blankets, sheets, towels, and washcloths will be furnished. These are excellent accommodations and the fee includes two nights lodging, five meals, two snacks, and all seminar materials.

**ARRIVAL TIME:** Registration begins Friday evening at 7:00 p.m. Central Standard Time (**dinner will not be provided on Friday**) - Session #1 starts at 8:00 p.m.

**WHAT TO BRING:** **A COMPLETE "CLASS A" SCOUT UNIFORM, INCLUDING SCOUT PANTS, IS REQUIRED.** It is necessary to bring an Order of the Arrow sash, OA handbook, toiletries, a change of clothing, and a flashlight.

**REGISTRATION:** The seminar is limited to the first 60 participants whose applications, with the required council approval, are received by the regional office. Faxed registrations will be accepted. The National Leadership Seminar has been written and designed for a limited number of participants who are 15 years of age or older. Training will address leadership, but will not contain lodge officer or section training. **Applications must be legible;** certificates will be printed in advance.
